**Course Articulation Agreement
Any Degree, Diploma or Certificate to B.S. Criminal Justice**

1. This agreement is made and entered into under the Memorandum of Understanding for Course Articulations signed in August 2017 by the Presidents of both institutions.
2. The joint program will be open to Oconee Fall Line Technical College (OFTC) graduates with any approved degree, diploma or certificate in Criminal Justice and only for candidates entering the B.S. degree in Criminal Justice major at Middle Georgia State University (MGA).
3. All OFTC courses transferred to MGA's general core (Areas A through F) OR to major requirements at MGA will be taught by qualified faculty with a minimum of a Master's degree and 18 graduate hours in the field.
4. **General Education Courses:** Effective January 2012, Middle Georgia State University accepts the general education courses for transfer as detailed in the articulation agreement between the University System of Georgia and Technical College System of Georgia. Courses will only be accepted from institutions accredited by the Commission of Colleges of the Southern Association of Colleges and Schools.
5. Qualified OFTC graduates may receive transfer credit for OFTC courses to be applied toward MGA's College of Arts & Sciences' Area F for a maximum 18 hours, i.e., up to 6 courses. **This list may be amended by written agreement of the Deans of the schools at each college.**

7. All MGA candidates for degree must complete a minimum of 120 semester hours of academic work with a grade point of 2.0 or better. The academic work must include at least 27 semester hours of upper level core courses in the major field and at least 24 semester hours of upper level electives in the major field.
8. Of the 51 semester hours immediately preceding graduation, at least 30 must be taken in residence at MGA. Any student admitted to MGA for the final year must be in residence for two semesters and must complete at least 30 semester hours in residence, including 27 hours of upper level course work in the major.
9. All University System of Georgia and MGA requirements for graduation must be satisfied.
10. This agreement is effective for students who graduate with a degree or diploma from OFTC beginning August 1, 2017.
