The analysis of our results has given us multiple angles with which to view the needs and utilization of technology on and off campus. We have observed that more students continue to prefer leveraging their own technology in some areas as well as utilizing the modern our PC's and labs. Further support by other university entities will allow us to greatly improve on this initiative. In our continued rollout of office 365 we have observed that users are utilizing the new features of the most recently Office environment and are organically working them into the workflow of their departments. Users have made it clear that they appreciate the reduction in space of newer desktop setups and the increased battery life of newer portable solutions and that the upgrade to both has been beneficial to their computing experience. The continued upgrades taking place in computer and AV systems in locations across the university allows up to provide both a modern learning and working environment for both MGA students and staff as well as outside entities. We continue to learn from both parties of technology and trends that they have encountered and work to meet the expectations of modern learners and workers.
